I. Outlines of the 22nd Ship for World Youth Program

1. Purpose of the Program

The purpose of the "Ship for World Youth" program is to broaden the global view of the Japanese youths, to promote mutual understanding and friendship between Japanese and foreign youths as well as to cultivate the spirit of international cooperation and the competence to practice it, and furthermore to foster the youths with capability of showing leadership in various area of international society.

In addition, this program aims at establishing networks and promoting joint activities among youths around the world through providing, as the concrete and practical opportunity, the cohabitation and the joint activity on the board of the "Ship for World Youth," which is the epitome of international society with wide variety of cultures and ideas, to make an visible international contribution from the perspective of human resource development.

2. Sponsorship

The Ship for World Youth program is organized and implemented by Director General for Policies on Cohesive Society, Cabinet Office of the Japanese Government.

7. Activities

(1) Activities in Japan

The Participating Youths (PY) shall partake in the following activities according to the schedule decided by the Director-General for Policies on Cohesive Society of the Cabinet Office (hereinafter refer to "Director-General").

- (a) Orientation concerning the general information of Japan as well as its youth administration and activities (excluding the Japanese Participating Youths)
- (b) Exchange of views among the PYs
- (c) Visit to youth-related facilities, cultural facilities, industrial facilities, etc.
- (d) Home-stay (excluding the Japanese Participating Youths)
- (e) Pre-departure Training Course

(2) Activities on board

The PYs shall partake in the following activities according to the schedule decided by the Director-General.

- (a) Course Discussion (Studies and discussions on the common issues from a global view point)
- (b) Introductions of each country
- (c) Club Activities
- (d) Sports and Recreational Activities
- (e) Others (Maritime Exercise, etc.)

(3) Activities in the countries to be visited

In the countries to be visited, the PYs shall partake in the following activities according to the schedule that the Director-General decides based on the separate guideline, taking into consideration consistency with the activities on board.

- (a) Courtesy Calls
- (b) Visits to various facilities
- (c) Exchanges with youths of the countries to be visited through sports activities, etc.
- (d) Other appropriate activities deemed by the governments of the respective countries to be visited

8. Duties and responsibilities of the Members

- (1) Administrator and Administrative Staff
 - (a) The Administrator shall represent the Government of Japan and command the operation of this program.
 - (b) The Deputy Administrator shall assist the Administrator and carry out the duties in his/her place in case of his/her absence.
 - (c) The Administrative Staff Members shall receive orders from the Administrator and manage the matters concerning the implementation of the program.

(2) Advisors

The advisors shall share their responsibilities in educating and guiding the PYs along the purpose of the program.

(3) Participating Youths (PY)

The PYs shall take part in the activities mentioned in above 7.

(4) Unit of Activities


< By Country>

- (a) National Delegation Leaders: NL
 - i) Lead and represent own delegation as the National Delegation Leader.
 - ii) Lead own letter group as the Group Leader.
 - iii) Act as a liaison person between Administration and the Participating Youths for smooth operation of the program.
 - iv) The NL shall cooperate with Administration for smooth operation in case of emergencies.
 - v) Participate in same activities as the Participating Youths in principle.

Note: For the Japanese delegation, there shall be one "Sub National Delegation Leader (SNL)" in addition to the NL. SNL supports NL and performs same role as NL.

- (b) Assistant National Delegation Leaders: ANL
 - i) The ANL shall assist and share responsibilities with National Delegation Leader.
 - ii) They act on behalf of National Delegation Leader in case of his/her absence.

Organizational Structure of Delegation




<By Letter Group (A-M)>

As a basic unit for the activities, 13 groups shall be organized with members from various countries. Each group will have one Group Leader and three Assistant Group Leaders (two Japanese Participating Youths (JPY)) and one Oversees Participating Youth (OPY)).

- (a) Group Leaders: GLEach NL shall assume the role of Group Leader and lead own letter group.
- (b) Assistant Group Leaders: AGL
 - The AGL assists and shares responsibilities with National Delegation Leaders whenever necessary in various activities on board and in the countries to be visited.
 - ii) The AGL acts as a liaison person for the group activities.
 - iii) In case of the absence of GL for any reason, AGL will act on behalf of GL.
 - iv) The AGL supports PYs' living environment at large, including currency exchange at each port of call and health care in each group by assisting the nurse of Administration.

1. Activities on Board

(2) Outline of Activities on board

a) Course Discussion

Refer to attached sheet.

b) National Presentation

It aims at having an understanding of each participating country deepened through introduction of various aspects such as politics, economics, society, culture, tradition and custom by playing dramas, music, showing pictures, videos and so on.

c) Sports & Recreation

Sports & Recreation aims at health maintenance and deepening friendship through sports and games.

d) PY seminars

The PYs take the initiatives to plan seminars, and run/ take part in them as well, that promote a mutual understanding and expanding PYs' international view.

e) Group Activities

Group Activities aims at deepening the unity of the group members and mutual understanding by performing various activities planned by them.

f) Club Activities

Club activities aim at learning other cultures especially technical learning about what requires cultural special skills etc. The PYs must belong to one club

g) Exhibition

The achievement of Club Activities and other activities will be presented.

h) Farewell Festival

i) Post Program Activities

The PYs discuss how experience which they got with the SWY will be put to practical use in the future.

j) Voluntary Activities

Voluntary activities are the activities besides the regular schedule which aim at the spontaneous exchange among the PYs through pursuit of a common interest and concern. Although the activities are fundamentally free, booking and permission are required for articles and public spaces.

Each PY has a role and takes a part in various activities on board.

4. Life on Board

(1) Daily schedule on board

a) Activity time on board is from 7:30 to 23:00.

b) Importance of keeping on time

Keeping on time is very important since your delay will affect programs and causes inconvenience to others.

Due to the time differences, clocks on the ship will be adjusted to the local time by 30 to 60 minutes. In visited countries, local time will be used.

(2) Outline of daily routine on board

a) Wake-up call

The group on duty organizes wake-up call for about 5 minuets from 7:30 a.m. by announcing or playing music on on-board public address system.

b) Hoisting of the national flags

National flag of country of the GL on duty will be hoisted with the national anthem of the country when the morning assembly is held in the Pacific Hall. When the assembly is held on Sports deck, all fourteen national flags will be hoisted with the national anthem of the country of the GL

on duty.

c) Morning Assembly

Every morning, group on duty organizes Morning Assembly. This is the opportunity for all PYs to gather and receive information from administration, lectures from the director and advisers, play games, or give notices from PYs to other PYs.

d) On-board activities

Tow periods both in the morning and in the afternoon are scheduled as on-board activities. (One period may be scheduled after dinner.)

e) NL(GL) Meeting

The meeting consists of all National Delegation Leaders and discusses and determines various matters happening on board.

f) AGL Meeting

Administration gives information to AGLs at the meeting and AGLs take them back and inform PYs at respective group meetings.

g) Group Meetings

GL and AGL share the information from GL and AGL meetings with PYs in respective groups and discuss them or other matters if necessary.

* Group on Duty

The group on duty of the day is taken turns every day among 13 groups (A to M group).
